1. Context

The Education and Training Reform Regulations 2017 (sch 4 cl 1 and sch 8 cl 1) require that the programs of, and teaching at SEDA College (Victoria) must support and promote the principles and practice of Australian democracy, including a commitment to:

- elected government; and
- the rule of law; and
- equal rights for all before the law; and
- freedom of religion; and
- freedom of speech and association; and
- the values of openness and tolerance.

Nothing in this clause is intended to affect the rights accorded to, or the compliance with any obligation imposed on, a registered school under a law of the State or of the Commonwealth.

2. Definitions

A reference or term included in this statement is defined as follows;

"SEDA College" or "the College" refers to SEDA College (Victoria).

3. Application

The College provides a curriculum and program approach that adheres to the principles by which Australian society is defined, including: a belief in elected Government; a commitment to the rule of law, to equal rights for all before the law; a belief in freedom of religion, freedom of speech and freedom of association, and embracing values of openness and tolerance.

- We believe in the values of openness and tolerance, and value and respect all members of the College community regardless of background.
