Please note that the Concession Discount only applies to the Tuition portion of the Student Fees and is pro-rated over the entire school year. Concession Discount is subject to approval of the Camps, Sports and Excursions Fund (CSEF) application which is assessed annually.

Please note for returning students: A re-enrolment deposit of \$1,500 is payable by 18 September 2025 for families electing payment options 1 or 2. For families electing payment options 3 or 4, the re-enrolment deposit is incorporated into the instalment amounts which commence in October 2025.

PAYMENT OPTIONS AND METHODS

A \$1,500 Confirmation Deposit is payable on enrolment as outlined above. The balance of the Student Fees may be paid under one of four options, outlined below.

Option 1	In full by 18 November 2025	Early Payment Discount** of 5% applied to total Student Fees
Option 2	In full by 19 January 2026	Early Payment Discount** of 3% applied to total Student Fees
Option 3	Monthly Payment Plan	Balance of Student Fees paid by monthly direct debit commencing 18 October 2025 , with payments finalised by 18 August 2026
Option 4	Fortnightly Payment Plan	Balance of Student Fees paid by fortnightly direct debit commencing 9 October 2025 , with payments finalised by 27 August 2026

** The Confirmation Deposit must be paid by the due date for this discount to apply.

Student Fees may be paid by one of the following methods.

- Direct Debit via Bank Account
- Direct Debit via Credit Card (Visa/MasterCard only)

Late Payment Charges

A **\$20 Late Payment Charge** will be incurred in circumstances where the scheduled payment is not received by the due date. If this occurs, the charge will be added to your Student Fee Account.

Other Charges

The following charges are payable in addition to the Student Fees:

- Optional camps, excursions and programs
- Notebook repairs (not covered by warranty) and accessory replacements

Invoices for these charges will be issued separately from the invoice issued for Student Fees. Payments for these charges are due within 14 days of receipt of the Tax Invoice and cannot be paid by incorporating them into the Student Fees Payment Plan.

THIRD PARTY PAYMENT OF STUDENT FEES

If Student Fees are to be paid by a third party, the Third-Party Payment Form must be completed and returned to SEDA College Finance via email (finance@scv.vic.edu.au). Please contact SEDA College Finance to obtain a copy of this form. SEDA College Finance will organise payment arrangements directly with the third party, however, the parents/guardians of the student will remain liable to pay the fees in the event that the third party fails to make payment.

UNIFORM

SEDA College (Victoria) and its Industry Partners maintain a strong position regarding student presentation and professionalism during the program activities. Students represent industry partners throughout their time in the program and it is a requirement that their uniform is kept and worn in a clean and tidy manner. For this reason, uniforms are issued prior to the commencement of each academic year and form part of the Student Fees. The Student Fees cannot be reduced by removing the allocation of a uniform.

NOTEBOOK

A notebook, stylus pen and charger are a compulsory and essential component of the program for all students. The use of this notebook, and any ICT support required, forms part of the Student Fees. It is the responsibility of the student to take care of the notebook and take reasonable steps to ensure it is not damaged, lost or stolen. Students are responsible for any costs relating to the repair or replacement of the notebook, stylus (where provided) or charger; if applicable, a Tax Invoice will be issued for these additional charges, payable within 14 days. **The notebook, stylus pen and charger will remain the property of the College until all Student Fees and any other charges are paid in full.** The notebook may be retained by the student at the completion of Year 12 provided that all Student Fees and other charges have been paid in full. **If the student leaves the program before the completion of Year 12 the notebook, stylus pen and charger must be returned to the College or additional charges will apply.** The Student Notebook Agreement will be signed by parents/guardians and students upon enrolment.

CONCESSION DISCOUNT

A Concession Discount on the Student Fees is offered to students who have a financial need in the form of a low family income. A valid means-tested concession card detailing the student's name is required for the student to be eligible for a Concession Discount. The concession card needs to be valid on the on **27 January 2026** and be eligible for the Camps Sports Excursions Funding (CSEF) to access this discount and the student must be enrolled at the College on the census date of 27 February 2026.

The Concession Discount is dependent upon the Department of Education and Training continuing to provide funding for concession card holders. The College may change the basis upon which the Concession Discount is offered if changes are made to this funding.

Please note that Concession Discounts are not backdated and must be applied for prior to the commencement of the school year.

NOTICE OF WITHDRAWAL

The equivalent of one term's notice must be given to the Registrar, in writing, for any student's withdrawal throughout the year or fees may be charged or forfeited (as the case may be) in lieu of notice. The Registrar can be contacted via email on registrar@scv.vic.edu.au.

Where a student is withdrawn from the College a Withdrawal Charge will be payable, depending upon the date at which the student is withdrawn.

The student's notebook, stylus pen and charger must be returned, or additional charges will apply.

Concession Information Sheet 2026

Students may be eligible to access a Concession Discount against Student Fees. Please read the information below and check the eligibility requirements.

The Concession Discount is dependent upon the Department of Education and Training (DET) continuing to provide funding for concession card holders. The College may change the basis upon which the Concession Discount is offered as a result of changes to this funding.

ELIGIBILITY

A Concession Discount on fees is offered to students who have a financial need in the form of a low family income. A valid means-tested concession card detailing the student's name is required for the student to be eligible for a Concession Discount.

The concession card needs to be **valid on 27 January 2026** be eligible for the Camps Sports Excursions Funding (CSEF) to access this discount. Please note that Concession Discounts are not backdated and must be applied for prior to the commencement of the school year.

The DET has advised that in order to be eligible for CSEF the financially means-tested concession cards must be valid on either:

- The first day of Term 1 (Tuesday 27 January 2026) or
- The first day of Term 2 (Monday 20 April 2026)

- Child Disability (CD)
- Family Allowance (FA)
- Ex-Carer Allowance (Child) Health Care Card
- Carers Card (CAR)

SUPPORTING DOCUMENTATION REQUIRED

Parents/guardians applying for a Concession Discount must send a copy of the completed CSEF Application Form, along with a copy of the eligible concession card (back and front), to SEDA College Finance via email at finance@scv.vic.edu.au. A copy of the CSEF form is included in this pack.

Where the concession card is found to be ineligible for CSEF funding the full Student Fees will be charged and are payable by the parents/guardians.

An application for a Concession Discount is valid only for the current school year. A new application must be submitted at the commencement of each school year to enable the eligibility of the concession card to be assessed.
